

## George and Emily Eden

Pride, Privilege, Empire and the Whigs

*Brigid Allen*

George and Emily Eden were a devoted sibling pair. Both unmarried, they were accepted as a mildly unconventional couple by friends in the dynastically conscious governing class. George (1784-1849) entered politics as a Whig to replace his elder brother, who had been groomed for success but drowned in the Thames off Westminster one January night in 1810. Four years later George inherited his father's peerage as 2nd Baron Auckland. In 1835 he was appointed Governor-General of India, and Emily (1797-1869), although reluctant to leave her close friend, the Prime Minister Lord Melbourne, went with him.

A witty and perceptive writer, who later published a distinctively voiced pair of novels, Emily chronicled the Indian period, as she did her entire adult life, in letters. Allen traces the development of her closeness to George, their interlocking private and public lives and the events that impacted on them, including the Afghan disaster of January 1842 and the mixture of blame and forbearance that George attracted at home. A poignant coda describes Emily's final twenty years as Victorian invalid, author, and observer of the political scene.

## Katharine Briggs

Story-Teller


*H.R. Ellis Davidson*

Katharine Briggs made an indelible mark on the world of folklore with her compilation of the *Dictionary of British Folktales in the English Languages*, while her subsequent *Dictionary of Fairies* confirmed her already distinguished place among British Folklorists. Briggs's initial academic interest while at Oxford University was in seventeenth-century literature and the Civil War. Upon leaving Oxford she pursued amateur dramatics and worked for the Guide Movement, and during the Second World War she served in the Women's Auxiliary Air Force. It was here, perhaps, that her personality fully matured; among other activities she delighted her fellows with her remarkable gift for story-telling.

After the war, her career as a folklorist began to blossom. As if to make up for lost time, she spent the last twenty years of her life writing and lecturing almost continually. As well as her books on folklore, she gained renown for her children's books *Kate Crackernuts* and *Hobberdy Dick*. She was responsible for revitalising the Folklore Society and as its President, she laid the foundations of the Society as it is today. Hilda Davidson's biography brings to life a remarkable woman whose combination of academic excellence and natural gift for narrative found her friends all over the world.



## Mirrored Minds

Søren Kierkegaard and  
Hans Christian Andersen

*Kate Ashton*

In her unique dual biography, Kate Ashton delineates the parallel lives of Hans Christian Anderson and Søren Kierkegaard, their personal relationship, literary careers, and lasting cultural influence on the western and wider world. These two towering literary geniuses followed radically divergent paths, and yet each read and reacted to the immense power and depth of the other's growing oeuvre as it refracted their own. Against the backdrop of the end of Golden Age Denmark within a warring Europe, and the spiritual and sexual repression of Reformed Christianity, each suffered the fate of the prophet unhonoured in his hometown of Copenhagen.

Tracing their lives from childhood trauma to tragic love affairs and anguished isolation, Ashton illuminates counteractive response to experience: one an inward search for truth and self-knowledge, the other flight into distraction and fantasy. *Mirrored Minds* offers the reader an opportunity to explore each author and his legacy within the context of the other, just as their long-standing association held up a mirror for Anderson and Kierkegaard themselves.






The story of how the map of New Zealand emerged is a fascinating one. The first full map of the continent was published in London in 1773, which might seem the natural starting point, but over the preceding 150 years, fragments of charts and intelligence about New Zealand ricocheted around various parts of the world. In *A Draught of the South Land*, Paul Moon provides the first comprehensive account of this piecemeal process.

Moon's investigation covers several continents over more than a century, and reveals the personalities, blunders, strategic miscalculations, scientific brilliance, and imperial power-plays that were involved. Above all, he examines the roles played by explorers and traders, Māori and European rulers, scientific societies and military groups, as well as specialist cartographers and publishers. At a time when maps as colonial tools, enablers of trade and objects of curiosity are being studied anew, his careful analysis and engaging narrative will be of interest to scholars everywhere.

**Paul Moon**, ONZM, is Professor of History at Auckland University of Technology, and his research focuses on nineteenth-century New Zealand and the philosophies of colonisation. He has doctorates in literature and philosophy, and is a Fellow of the Royal Historical Society at University College, London. He was a finalist in the 2014 Ernest Scott Prize in History for his book *Encounters: The Creation of New Zealand*, and a finalist in the 2022 History Reclaimed International History Prize for his book *Colonising New Zealand: A Reappraisal*.



## The History of Morris Dancing, 1458-1750

Morris dancing, one of the more peculiar of the English folk customs, has been greatly misunderstood. In *The History of Morris Dancing, 1458-1750* John Forrest analyses a wealth of evidence to show that Morris dancing does not, as is often assumed, have pagan or ancient origins. He examines early documentation to draw Morris traditions into the wide area of communal custom and public celebrations, showing the passage of dance ideas between groups previously considered folklorically distinct.

## Before Tom Brown

The Origins of the School Story

*Robert J. Kirkpatrick*


The use of school life as a closed narrative environment is well documented, and modern examples such as *Malory Towers* and *Harry Potter* show the genre’s continued appeal. While there have been several histories of the school story, especially in children’s literature, almost all of them take as their starting point *Tom Brown’s Schooldays*. Although occasionally acknowledged in passing, there has never been a complete study of earlier school stories, or of other fictional portrayals of school life before the middle of the eighteenth century.

In *Before Tom Brown*, Robert Kirkpatrick traces the roots of the school story back to 2500BC, when school life was a feature of Sumerian, Egyptian and Graeco-Roman texts written as teaching aids for children. From Chaucer’s *Canterbury Tales* to Shakespearian comedies, he explores for the first time the use of school dialogues in the classroom, in print and on stage, and presents new evidence that the first school novel appeared in 1607. Finally, he examines the role of the school story in the broader development of the novel as the genre became established through the eighteenth century. Readers will be rewarded with a whole new perspective on the history of children’s literature.

**Robert J. He is a long-standing member of the Children’s Books History Society (and the Society’s Secretary since 2010), and has twice won the Society’s Harvey Darton Award.





## The Older Liszt

Music, World and Spirit

*Peter Coleman*


Franz Liszt is well known for his early years as 'superstar' pianist who excited audiences throughout Europe, but his later life is also of great interest. In his final 25 years he sought to achieve his life's aims of promoting new forms of music and giving stronger witness to his Christian faith, while continuing to support his stalwart life partner Princess Carolyne. However, he was to face unexpected problems in the continued negative reception of his music and recrimination in his closest relationship.

Drawing on detailed analysis of Liszt's correspondence from his fiftieth year onwards, Peter Coleman approaches his later life as a case study of an older person grappling with a succession of often disturbing life experiences. These included the deaths of two of his children, political upheaval and war within Europe, and a growing realisation of his own past failings. Liszt suffered frequent bouts of depression but never ceased composing music nor steadfastly heeding Christ's command to bear one's cross. This sensitive treatment of an extraordinary individual will appeal to the scholar and general reader alike.



## R.C. Hutchinson

The Man and His Writing

*Barry Webb*

In *R.C. Hutchinson*, Barry Webb reclaims the legacy of a highly-acclaimed, yet often forgotten writer. Despite having been awarded the Sunday Times Gold medal for fiction, the W.H.Smith award for the best novelist of the year, being short-listed for the Booker Prize, and several of his 17 novels becoming best-sellers in the UK and America, Hutchinson has not withstood the test of time compared to his contemporaries. Combining Hutchinson's own reflections with insightful critical analysis, Webb traces Hutchinson's thoughtful, observational life alongside his extraordinary literary output. He draws out how Hutchinson's firmly held Christian beliefs allowed him to eschew didacticism for nuanced reflections on the nature of human suffering.

Part biography, part critical study, *R.C. Hutchinson* sheds light on this influential and gifted writer, contextualising his work and highlighting his genius. He was described by Sebastian Faulks as a 'mid-century master of the genre', and Cecil Day Lewis CBE as 'one of the very few living novelists who will be read fifty – even a hundred years hence'; Webb joins these writers by offering readers the opportunity to rediscover this exceptional writer.

## Ritual and Drama

The Mediaeval Theatre

*Francis Edwards*

In *Ritual and Drama*, Francis Edwards reveals that ritual forms the basis of all popular theatrical entertainment, the root from which dramatic art has grown. Covering the period from the tenth to the fifteenth centuries, Edwards focusses on the audience impact rather than the artistic qualities of the mediaeval plays, devoting much of his attention to the emotional effect of religious and dramatic ritual on the spectator. Illuminating the impact of Christian rituals, liturgy, and stories, Edwards draws illustrative parallels between mediaeval and modern states of mind.

*Ritual and Drama* describes the growth of the dramatic idea, the styles of presentation of the mystery cycles, and the evolution of the morality play, presenting in straightforward terms a theme fundamental to our understanding of mediaeval dramatic art.



*Patrick Carnegy*

Since 1967 and his first visit to Bayreuth for *The Times*, **Patrick Carnegy's** principal research interest has been the stage history of Wagner's works. Dr Carnegy's books include *Faust as Musician* (1973), a study of Thomas Mann's *Doktor Faustus* (1973), and the critically acclaimed *Wagner and the Art of the Theatre* (2006), which won a Royal Philharmonic Society Music Award, and, in the USA, a George Freedley Memorial Award for its 'outstanding contribution to the history of the theatre'.







**David L. Frost** was Professor of English at the University of Newcastle, Australia, and is a former Fellow of St John's College, Cambridge. He served for a time as a member of the Church of England Liturgical Commission.



## A Grundtvig Anthology

Selections from the Writings of N.F.S. Grundtvig (1738-1872)

*Edited by Niels Lyhne Jensen*

A notable figure in the cultural and social history of Denmark, Nikolaj Frederik Severin Grundtvig's (1783-1872) works are still salient for us now. Highlighting his vivacious ideas and personality, *A Grundtvig Anthology* includes extracts from Grundtvig's historical, educational, theological, devotional, and poetical works. Each chapter is prefaced by insightful explanatory introductions by leading authorities on Grundtvig's monumental body of work, along with a comprehensive general introduction and illuminating annotations.

Grundtvig viewed the myths of the North as an expression of the moral values and understanding of life, and his hymn and song writing reveal the same joy of life, openness and freedom as the Norse perspective. By offering selections from across his major works, this anthology succeeds in capturing his spirit in English translation, and continuing his written legacy.

**Nikolaj Frederik Severin Grundtvig** (1783-1872) was a theologian, priest, poet, writer and teacher who left an indelible mark on the life and culture of Denmark. A contemporary of Hans Christian Andersen and Søren Kierkegaard, and cited as one of the greatest poets in the Danish language, he left a great legacy which is still felt in public life and cultural activities in Denmark.

**Niels Lyhne Jensen** (1921-2001), lecturer and amanuensis, joined the Nordisk Institute at Aarhus University in 1969, having taught Scandinavian literature at Newcastle University. He wrote numerous articles and books on literary and historical subjects.

**Edward Broadbridge** moved to Denmark in 1967, learning its language and culture. He specialises in translating Grundtvig's works into English.





## Julian of Norwich and the Problem of Evil

Richard Norton


Julian of Norwich's *Revelations of Divine Love* grapples with the same fundamental question that has vexed philosophers and theologians since the advent of monotheistic religion, and continues as a barrier to belief for many today. Namely, if God is so good, how can natural disaster, genocide, trauma – and my present suffering – occur? Historically, there have been two apparently very different approaches to the problem: the pastoral, or practical, on the one hand and the systematic on the other.

However, Richard Norton suggests that these two lines of thought may not be as separate as they seem, and may indeed be dependent on one another for their cohesion. Drawing on Julian's medieval experience of personal and population-wide suffering, alongside that of more recent theologians such as Dorothy Solle and Jürgen Moltmann, Norton constructs a compassionate model of theodicy that can be of use to both pastoral and systematic theologians. Throughout, he remains sensitive to the raw atrocity of evil, while preserving a vision of God as the one who ensures that *all shall be well*.



## A Prayer for All Seasons

### The Collects of the Book of Common Prayer

*A Prayer for All Seasons* contains the collects from the Book of Common Prayer. Starting with the collects for Morning Prayer, followed by those for Evening Prayer, and continuing with those for Christmas, Easter, and other seasons and feasts, and for Saints’ Days, and concludes with those for Holy Communion. While the prayers themselves date back to the times of Popes Leo I, Gelasius, and Gregory the Great, the wording of the collects was largely written by the sixteenth-century liturgical genius and Archbishop Thomas Cranmer, the main author of the Book of Common Prayer.

The wonderful collects in the book are framed by early-twentieth-century wood engravings by Blanche McManus which augment and enhance the beauty of the language. Time and faith have hallowed the Book of Common Prayer as one of the supreme achievements of the English language with its splendour.

In addition to a Foreword by the former Prince of Wales, Prince Charles, the book contains an introduction by Ian Curteis, and an Afterword by The Right Reverend Richard Chartres, former Bishop of London.


## The Quest for Love Divine



In the ancient world, writings were read aloud, heard, and remembered. In contrast, modern exegesis assumes a silent text. For Margaret Lee and Brandon Scott, the disjuncture between ancient and modern approaches to literature obscures the beauty and meaning in writings such as the New Testament. As the structure of an ancient Greek composition derives first from its sounds, and not from the meaning of its words, sound analysis, analysis of the signifier and its audible dimension, are crucial to interpretation.


